

Milwaukee's Community Health Centers

Health Care Home

In 2006, Milwaukee's four federally-funded Community Health Centers served as the medical home to over 60,000 area residents. If not for the Health Center in their community, many would have had difficulty accessing health services due to their linguistic, financial, or geographical barriers.

Safety Net

Each Health Center provides care to anyone who walks in their door, regardless of insurance status or ability to pay. Therefore, Milwaukee's Health Centers make up the core of health care safety net providers who serve people in need.

Patient Care

Health Centers provide comprehensive primary health care (i.e., medical, dental, and mental health care) for adults, children and families. Most services are provided on-site. Some maintain evening and/or weekend hours, all provide care at multiple sites and employ multilingual staff.

Governance Structure

Health Centers are private, non-profit corporations created through the initiative of local citizens interested in bringing health care to their areas. They are governed by consumer-majority boards of directors, and thus truly represent the community they serve.

Funding

Health Centers receive federal and state operating grants. They are required to bill third-party payers for the patients who have coverage, which helps offset the cost of the Health Center's other operations. This allows them to spend their federal grant dollars to cover the cost of caring for the uninsured.
